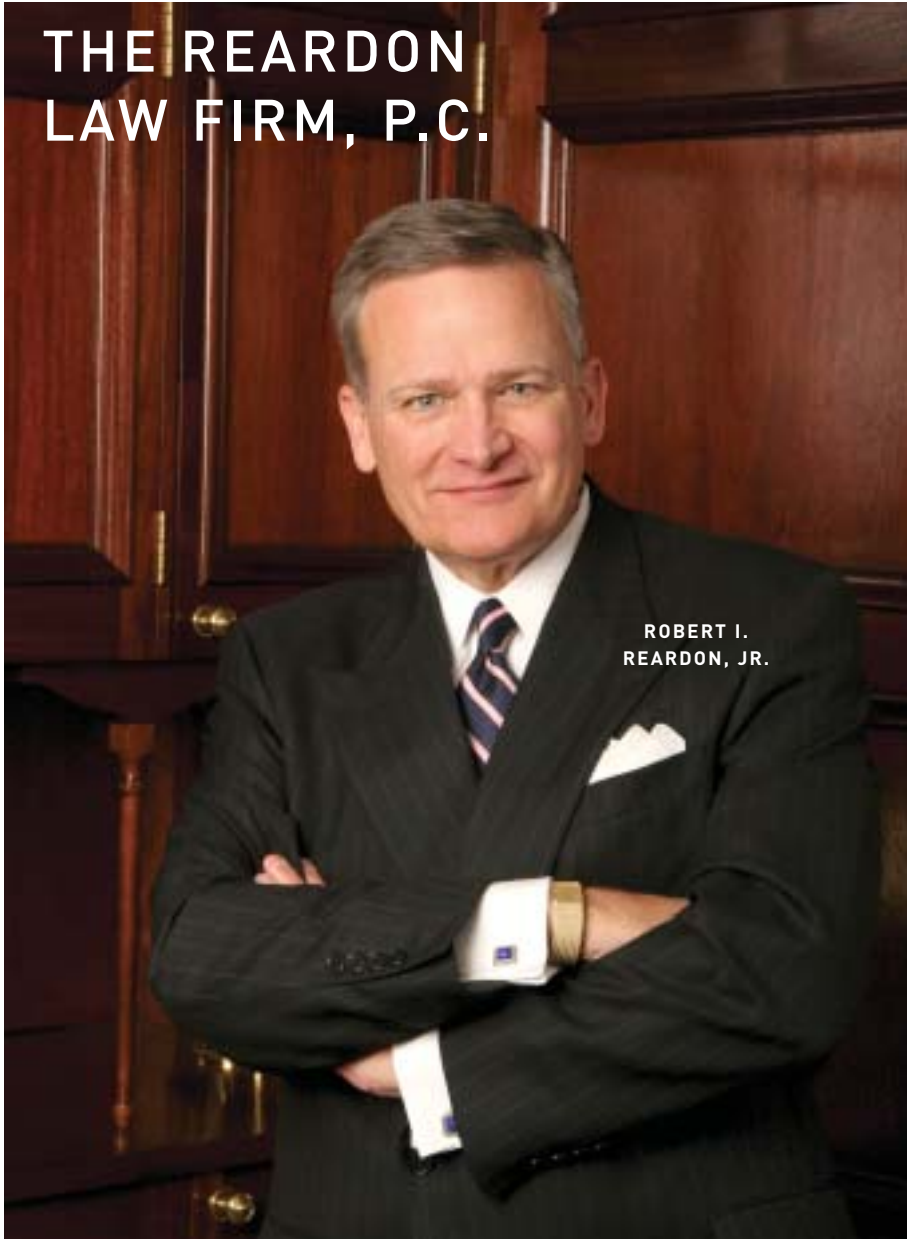

After spending three years in the United States Marine Corps as a JAG Officer prosecuting and defending courts-martial, including murder cases, Reardon came home to Connecticut over thirty years ago to join a successful litigation firm established nearly one hundred years ago. By 1984, Reardon assumed the presidency of the firm and has carried on its tradition of winning. He has served as President of the Connecticut Trial Lawyers Association and as a Governor of the Connecticut Bar Association. He is currently the Connecticut Governor to the Association of Trial Lawyers of America and is Board Certified as a Civil Trial Lawyer by the National Board of Trial Advocacy. **SUCCESS MEANS SAFETY** Reardon has always focused on accountability for those responsible, and results for the victims. A recent trial involved a subcontractor construction worker who was completely buried after a trench collapsed on him, leaving him with a permanent disability. During the 2005 trial, the jury determined that the general contractor construction company was negligent in its failure to enforce safety requirements during the excavation, and Reardon secured a \$6 million award for his client. "The company refused to settle and, after an eight week trial, I was pleased the jury sent a message that general contractors are required to enforce safety procedures for the protection of everyone at a worksite," Reardon says of the results. "The award is fair as it will provide for my client for the rest of his life."
